Donkey Skin Trade: raise awareness and support initiatives to alleviate the donkey population crisis. In Zimbabwe we support an equine sanctuary that rescues and provides care for over 140 rescued donkeys. In Israel we support a rescue and rehabilitation centre that cares for over 900 animals including donkeys, horses, goats, and cats. In South Africa funds were made available to assist with the extension of paddocks for rescued donkeys. In Tanzania we have supported grass-roots partners with funding for mobile clinics which gave veterinary care to over 1,600 donkeys. In Kenya, which is particularly hard hit by the effects of the donkey-skin trade, we support efforts to rescue donkeys and report illegal donkey capture and trade.

In Zimbabwe we provide funding for the only no-kill shelter that houses over 600 rescued cats and dogs.

Street Animal Crisis: funded TNVR programs in Greece, Morocco, Kenya, and Jordan for street cats and dogs. Human Conflict: funds provided for the rescue and care of animals caught in war zones in Europe and the Middle-East. NFA funded the evacuation of animals from Middle-East conflict-zones.

Leading up to FIFA's world cup committee visits in December 2024 to ratify decisions on Morocco hosting the 2030 Football World Cup, NFA campaigned to highlight the widespread killing of street dogs through a petition and newsletters.
